President's message...

Hello neighbors! Autumn is upon us and I have some good news. We are just slightly under 60% membership which is the highest this Association has ever had in its entire history! Many of the new members are new residents in the Terraces who are very excited about living in the area and are happy to support their Association (unlike some who would see us decline if they had their way). Of course you know that I am speaking of the small subversive faction lead by Mrs. Betty Carmen of 275 Urbano Drive, and supported by one of our cently resigned Board members, Mrs. marsha Fontes of 545 Junipero Serra Blvd. Mrs. Fontes uses her Merced Independent leaflet to spread as much negative news about your Association as possible. These two people and their small band of followers have had everything from secret meetings with city officials, to writing the State Attorney General -- always with thought of disrupting what members voted on last year. Of course you know that I am speaking of the mandatory dues. So far these people have had little or no success, but I must tell you that it is very difficult your Board to accomplish urgently needed matters with this faction disrupting meetings in order to try and get their point across. To give you an example, Marsha Fontes came to our May meeting to inform us that she and Mrs. Carmen had petitions signed and meetings (in secret) with city officials to prevent us from obtaining title to our four mini parks. As usual, Marsha was uniformed. She did not know we had already decided sometime before not to obtaining title to these parks cause of the tremendous expense of the

mability insurance. If these people had only contacted their Board it would have saved much time and trouble. When we informed Marsha of the Board's decision on the parks, she was quite startled and quickly left the meeting. She then came to the June

meeting with a few of her "followers" saying, "I am here just as an observer this time." The following week she used almost the entire front page of her leaflet to pan the Board and the Association. We on the Board feel this is unfair, but I know that most of you realize and appreciate what your Association is trying to accomplish for you. Mrs. Carmen, who we feel has become completely obsessed by all this, filed a complaint with the Attorney General's office. She gave only her view of the procedure for mandatory dues (most of which was misleading and improperly reported) and is now involved in a campaign of sending bogus postcards to Terraces residents using District Attorney Arlo Smith's name as if he were endorsing this small group. I was sure that Mr. Smith, wouldn't knowingly lend his name to an underhanded project and we contacted him explaining what procedure was followed. I even sent him one of the cards so he might see how Mrs. Carmen and her little group are using his name. Well! (continued on page 2)

Membership...

Membership for 1986 is at an all time high! We have 426 homes that have pair dues, which is 58% of all homes in Inglesid-Terraces. A very small number of people have resigned. The statistics breakdown as follows: Total resignations = 54 (7%). 11 of these 54 still sent financial contributions. The 54 resignations were also broken down into two categories. 1. Homes that had never paid dues before = 33. 2. Homes that had annually supported the Association prior to the mandatory dues issue = 21. A further study revealed that many of the past non-supporting homes that resigned had at one time been confronted by the Association for either a covenant violation or general complaint. ITHA does regret losing the 21 former members who are protesting mandatory dues by abstaining support. However, the 47 newly acquired members did result in a desperately needed financial gain.

Now just think what would happen if everybody resigned and refused to pay dues! It would probably be the end of ITHA altogether. This is what could happen:

- 1. Nobody would be willing to work on a directorate where there is no possible way to accomplish anything.
- 2. It is a sure guarantee that park maintenance will cease.
- 3. If you have a neighbor violating a covenant - you'd be on your own. (Wait until you see the cost of legal fees!) Is this what people who have resigned really want? The reality is, that in order to provide you with services, adequate funds MUST BE AVAILABLE. It's that simple. It is obvious why a covenant violator doesn't pay dues and would want to see the Association disban! So if you have been incited to you should think about consequences of the action and how if could affect the neighborhood. In the meantime, remember your Association is trying to preserve and promote quality to all homes. only do this with can membership dues,





We have replaced the broken bench in Entrada Park and continue to remove graffiti from our gates, trellises and signs.

It is so gratifying to see that despite the fact that Mrs. Carmen and her allies have sent out cards and letters to everyone in the Terraces urging members to resign or not join ITHA, that our membership is the largest by far in its history. It is ironic that those who do not want mandatory dues are the very ones who do not seem to care that the will of the majority of Terraces Homeowners has over and over again shown support for it. This small but active minority has tried every way to subvert, thwart, and undermine the democratic process. They have held secret meetings and invited S.F. Supervisors, but never anyone from your Board of Directors, or anyone representing the opposing points of view which are clearly held by most of ir residents. Their actions demonstrate a platant contempt and disregard for the way democracy is supposed Fortunately they are a small minority.

When I personally went from door to door in my area, I found only about 2 persons in 10 who opposed the point of views of the elected Board of Directors of Ingleside Terraces. Their opposition ultimately doomed to failure. is unfortunate, too, that they have succeeded spreading false information to uninformed. Let us hope that since we now have the income to do so many of the things we wish for our parks and gates that we will not have to use it in the cause of sustaining the will of the majority against who refuse to accept responsibility and duty by paying their dues of only \$25 once a year. The day of the "free lunch" has gone the way of the nickel bus ride.

On a brighter note, we are pleased to report that Luciano Cattaneo (a resident of rona Court) has graciously volunteered to water the Corona Circle Park. The Board is pleased to have a new helping hand. Thank you Mr. Cattaneo!

The following two letters are in regard to our four mini-parks. We think you will find them interesting.

The purpose of this letter is to request information and clarify several recent issues between Ingleside Terraces Homes Association and San Francisco's Department of Public Works, Department of Parks and Recreation, Department of Urban Forestry, the Board of Supervisors, and Mayor Feinstein.

1. The Board of Directors of Ingleside Terraces Homes Association (ITHA) requests a written explanation from the Department of Public Works as to why the city cannot or will not maintain their following properties: Corona Court, Entrada Court, Lunado Court, and Moncada Court. ITHA has been held responsible and accountable for the appearance and maintenance of these four mini-parks for the past 47 years. The following is a sample of gardening expenditures in just the past four years:

1983 1984 1985

\$5,027.14 (Entrada \$3,336.48 \$3,861.38 \$4,134.01 Restored)

These figures do not include the valuable time and labor by numerous residents that performed volunteer gardening, major tree pruning, and regular watering. 1THA has paid a private gardener to cut the lawns and trim the trees in order to preserve the beauty of our neighborhood parks, and help maintain property values in our neighborhood. Families from all streets in Ingleside Terraces (which contains 731 homes) enjoy visiting and using our neighborhood's unique open spaces. As taxpaying homeowners, they are all entitled to an answer.

- 2. Our manual of ITHA states that one of our purposes is to "care for the maintenance and improvement of the parkways". Does anybody know how this agreement was established?
- 3. The Department of Public Works has recently suggested a joint effort in maintenance. We are willing to negotiate this endeavor and request that a written contract be presented and filed with the Board of Directors of Ingleside Terraces Homes Association. Our business meetings are held the second Thursday of every month at California Federal Savings (Ocean Avenue and Woodacre) in Lakeside Village. We would welcome a city representative to discuss these issues.

We would also like to take this opportunity to bring it to the attention of the Department of Public Works that Moncada Park is in dire need of a major tree pruning of its tall cypress tree and the concrete pathways that trail through this park are raised and cracked due to tree roots. We would appreciate a tree pruning crew and some cement workers to commence repairs as soon as possible. Another necessity for all four mini-parks is automatic sprinkling systems. Neighborhood volunteers should not have to spend their time setting up hoses and sprinklers and then constantly have to move them to insure complete water coverage.

It must be made clear that ITHA has been financially struggling. Due to OUR maintenance costs of the four mini-parks, we have been unable to accomplish our other purposes and objectives. We want the best for our neighborhood and therefore had asked for the titles to these land spaces as an ultimatum to achieve recognition of our situation and perhaps gain assistance to find solutions. Due to unaffordable liability insurance, we are unable to pursue this issue further. But regardless of who owns title to these parks, the evidence is conclusive: We all want these parks maintained!

Hopefully we can work together to resolve all of these problems. Ingleside Terraces homeowners are looking forward to your responses.

Summertime Blues

Summer 1986 brought a rash of complaints and reports of crime and vandalism in our Terraces. Topping the list were several letters from Ingleside Terraces residents that have experienced terrible confrontations with the students that attend the Wildshaw School on Ashton Avenue. Neighbors reported witnessing dealings, as well as students loitering around their homes using foul language, blasting music, littering, setting fires in yards, and worst of all being threatened by use of a gun. ITHA quickly notified the S.F.P.D. and filed an official complaint. the principal of the school notified. Although we have not received a response from Wildshaw School, the police department did order additional patrol cars in the vicinity and asked to be kept informed of this situation.

In July, the ITHA President received a call regarding a vandalism spree in the Cerritos/Lunado area. Several residents found their car windows bashed and broken, and a boat was stolen from out of a driveway. It was also reported that an elderly man was mugged in Lunado/Mercedes area.

In the last week in August, two garden statues were stolen from the front porch of a home on De Soto Street. The two statues (one of a boy - the other a girl) may still be in the neighborhood. It is believed that some young beer drinkers swiped the statues in the middle of the night just as a mischievous joke. Beer cans were the only evidence found on the lawn and in the gutter the following morning. If you found these statues mysteriously stuffed in your hedges or garden, please notify ITHA. They have sentimental value to the owner.

Hopefully things will settle down now that school is back in session. We would like to take this opportunity to encourage neighbors to share in a neighborhood watch program. Get to know your neighbors and phone numbers where they can be reached.

Board Action Taken

The following is a list of Board actions taken this year:

- 1. ITHA arranged to replace the large cement ball that was toppled from the Holloway/Junipero Serra stone pillar.
- 2. ITHA encouraged the DPW to pave the streets in our neighborhood.
- 3. ITHA has started investigation proceedings about our four mini-parks and is trying to get a written agreement from the DPW regarding park maintenance.
- 4. ITHA has requested tree pruning crews for Moncada Park. Cement crews were also requested to repair the pathways.
- 5. ITHA has replaced the broken bench at Entrada Park.
- 6. ITMA acquired police assistance to help resolve complaints regarding Wildshaw School students and our neighbors.
- 7. ITHA is investigating the costs of replacing the lights at the Mercedes Gateway.
- 8. ITHA continues to maintain the four mini-parks by providing a gardener.
- 9. ITHA is seeking additional legal counsel to help alleviate covenant problems.



Dear Mr. Hummel:

This is in response to your letter dated July 18, 1986 regarding maintenance of four mini-parks located in the Ingleside Terrace District.

These mini-parks were deeded to the city in 1939 and placed under Public Works' jurisdiction. Prior to 1939 the parks were owned and maintained by the Ingleside Terrace Homes Association.


Maintenance of these parks has never been an issue with the Department of Public Works. The Department believes that the Ingleside Terrace Homes Association has voluntarily and routinely performed the maintenance, without city assistance, for the past 47 years as a carry-over trend from its original structure.

The Department is uncertain about the park maintenance agreement in the Ingleside Terrace Homes Association's manual. We have issued maintenance agreements to homeowner associations and individual property owners to maintain city property under our jurisdiction. However, there is no such agreement that exist between the Ingleside Terrace Homes Association and the Department of Public Works.

Maintenance inquiries received by the Department express a division between the Ingleside Terrace Homes Association Board of Directors and certain homeowners that are not members of that organization. The Department would like to see a consensus among residents of the Ingleside Terrace District.

We are prepared to trim the cypress trees and repair the concrete pathways at Moncada Park. We do not presently have the funding to install automatic sprinkler systems at any of the mini-parks that are currently being maintained by the Ingleside Terrace Homes Association.
