

#### **CRIME PREVENTION**

It was made clear during our May 9th meeting introducing Patricia Bell of S.A.F.E. (Safety Awareness for Everyone) and Officer Hogue of C.P.O.P. (Policecommunity relations) that safety in our community cannot be the sole responsibility of the local police department, primarily because of a lack of uniformed police officers. Additionally, our community has the dubious distinction of being a low crime rate area, and thus a low priority when it comes to allocating man power. During the meeting we learned that we can best protect ourselves, our families and our possessions through community organization and education.

The C.P.O.P. program returns us to the days of a beat cop. A specific officer is assigned to an area. He/she patrols the area by foot, car, bicycle... The residents get to know the officer and the officer gets to know the area and its specific needs. There are a few drawbacks to this program for our particular area. First, the program is not yet in effect for our area, and no specific commencement date could be pinned down. Second, it appeared that this program would, by necessity, center mostly on the commercial areas of a particular territory. But, more importantly for us, this program takes place during daylight hours only, and our quiet community

seems to suffer most during the night hours when vandals, burglars and drive-by purse snatchers can hide in the dark. So, while we will enthusiastically welcome a C.P.O.P. program to our neighborhood, we must look to other alternatives for our specific needs.

S.A.F.E., formerly Project S.A.F.E., is a community group that helps establish neighborhood watch programs. S.A.F.E. provides technical assistance and information on how to bring neighbors together to discuss concerns and find solutions. They will provide information about better securing your home and identifying your belongings through engraving. Neighborhood watch areas are identified by outdoor signs, which in themselves have been proven to deter criminal activity. A neighborhood organization is our best bet at taking control of our streets and bringing safety to our community.

Finally, it was brought to our attention that police man-power is allocated by a review of the calls received from any specific area. We all know that the chances of the police recovering a stolen car or catching a vandal are extremely remote, so few of us bother to report such crimes. But, YOU MUST! We have to go on record with the police department every time a crime takes place in our neighborhood. We must let the police know that a quiet community is not without problems and concerns, and cannot be overlooked. Please, report ALL illegal occurrences so that the time and nature of the crime will go on record...for the sake and safety of us all.

## TREE UPDATE

The great turn-out at the May 9th presentation by the Friends of the Urban Forest has started the ball rolling for planting trees in Ingleside Terraces. The enthusiastic group of homeowners of all ages watched a short slide show on trees presented by F.U.F. coordinator Bonne Mieke. This was followed by a question and answer period and then yummy refreshments provided by our social chairs, Kerry Daly and Cheryl Thanos.

Bonne was very helpful and knowledgeable about trees. Here are some of the things we learned:

- Trees are not water guzzlers.
  They actually require only about
  10 gallons a week (the equivalent of 2 toilet flushes).
- 2) Types of trees that crack side-walks and streets are no longer permitted by F.U.F. or the Dept. of Public Works. By deep watering through a tube in the ground installed at planting, trees can be encouraged to root very deeply, preventing problems with surface roots.
- Since our sidewalks are narrow, F.U.F. has approved planting trees in our front yards. As this eliminates the need for a concrete-breaking contractor, it simplifies the tree permit application process and reduces the cost of planting.
- 4) Trees really do make a difference in the appearance of a


neighborhood. Bonne's "before and after" slides of various SF streets were inspiring!

The upshot of the meeting was that a group of homeowners signed up right on the spot to plant one or more trees on their property, and after they talked with their neighbors, we had enough people for our first tree planting.

F.U.F. is meeting with us again as a group on July 24th to show us the different types of trees that will grow well in our area, help us choose the proper varieties, teach us how to plant and care for the trees we choose and guide us through the permit process. (If you missed the first meeting, but want a tree, this meeting is a must!) Then they will dig the holes where we want them (after they check with city planning to be sure sewer and gas lines are safe). Our trees will be delivered the day before planting along with the stakes and ties. On the morning of the planting, Friends of the Urban Forest volunteers come out to help us plant all the trees before noon. Then we will sit back and enjoy a pot-luck meal and great satisfaction.

Our first tree planting is set for September 14th. Watch for the activity!

If you miss out on phase one of our neighborhood planting, you can still be part of our neighborhood beautification. We are planning to schedule a second planting for early next year. #### LAND OF FRUITS AND VEGETABLES OR ALL'S RIPE WITH THE WORLD

Fruits and vegetables will be as plentiful as stars and stripes this Independence Day month. Good weather has produced a bumper crop for July...and the lowest prices of the year, so far!

Freezes and droughts in 1989 and 1990 lowered supplies and raised prices, but that is not the case this summer.

You can expect all these items to be in abundance and at a low price: green beans, yellow squash, cherries, tomatoes, cantaloupes, watermelons, blueberries, peaches, honeydew melons, plums, apricots and grapes.

In addition to a bonanza of fresh produce, you can count on big discounts on canned and frozen vegetables because suppliers want to clear out their warehouses to make room for the new harvest.

Bananas are the only blemish on summer produce this season — they will remain at higher than normal prices because of the recent earthquake damage in Costa Rica. Torn-up roads have made it difficult for farmers to get their crops to market on time.


## **COVENANTS CORNER**

Here are simplified versions of a few of the ten "covenants and conditions". These covenants apply to all homes and lots in Ingleside Terraces. All ten will be covered as this series continues.

This installment of four covenants establishes the Terraces as strictly for single-family homes, one per lot, with no subdivision allowed.

- 1. The only thing that can be built on any lot is one single family house (and appurtenant structures like a garage). The only thing that house can be used for is a residence.
- 2. No flats. No duplex residences. No apartment houses. No lodging houses. No hotels. No boarding houses. You can not build these, and can not use your house as any of these.
- 7. No stores. No saloons. No grocery stores. No mercantiles businesses. No manufacturing or dealing in beer or liquor. No lot can be used for any purpose other than residential.
  - 8. No lots can be subdivided.

Note: This is the second of a series of the Ingleside Terraces restrictive covenants. The series is intended to reaquaint homeowners and residents with these restrictions. The articles are authored by Covenants chairperson Bob Mosher, with an assist from the 1989 simplified version of the covenants.

#### Dear Captain Welch:

On behalf of the Executive Board of the Ingleside Terraces Homes Association, I wish to extend to you a somewhat belated welcome to the Taraval Station and hope your tenure here will be a positive and rewarding experience. I look forward to establishing a positive, on-going working relationship with you and your officers in my capacity as the liaison between our association and the San Francisco Police Department.

My first official request concerns the shortage and often lack of drive-by calls by radio cars in our neighborhood. Ingleside Terraces consists to 732 homes and our boundries are Ashton Avenue, Holloway Avenue, Junipero Serra Boulevard, and Ocean Avenue. The majority of households in our neighborhood strongly feel that they are receiving inadequate coverage for the San Francisco Police Department. These concerns have been brought to the Executive Board's attention at several recent meetings.

Given the realization that we are not a "crime-ridden" neighborhood and therefore a low-priority area in respect to coverage, the fact is that unless this coverage situation improves, we may eventually become another priority area. Therefore, I urge you to give top priority to this very troublesome situation and take the appropriate corrective action.




